

Rules for QRSC Membership Card

- 1) The Member is responsible for their membership card as issued and they should value and care for their card at all times. When attending the club they must have their card in their possession at all times.
- 2) The Member must pay the renewal fee, as set each year by the Board of Management, each and every year for the membership card to remain valid.
- 3) The Member must advise the club of any changes to their membership details, including but not limited to – address, contact details including email. Failure to do so may jeopardise their membership rights.
- 4) The Member must pay a fee, as set by the Board of Management, if loss or damage occurs to the card.
- 5) Any Membership discount associated with the card will be set by the management and may fluctuate with different products purchased and from time to time.
- 6) Members are free to pay any sum they find appropriate into their account and use this credit on purchases Over the bar or to pay any subscription fee owed to the club. The balance will not earn any interest. The balance is fully withdrawable upon request (with 24 hours' notice to allow sufficient club funds to be on hand).

Quinns Rocks Sports Club By-Laws

The Quinns Rocks Sports Club shall be responsible for the Club-house and surrounds, and shall have jurisdiction in matters which affect more than one club.

1. A visitor or guest shall not be supplied with liquor to be consumed other than on the premises.
2. All visitors must be signed in by the member inviting them, and that member is responsible for them and their behaviour while they are on the Club premises.
3. The maximum number of times that one person shall be signed in before being required to apply for membership and pay membership fees shall be 3(three) in any one Club financial year. This restriction shall not apply to persons attending fund raising events such as bingo.
4. No liquor shall be supplied or sold to any person under the age of 18 years, and no person under the age of 18 years shall be admitted to any part of the Club premises where liquor is sold or consumed, unless they are accompanied by a person in authority over them, within the meaning of the Liquor Licensing Act (1988), and then only for the purposes provided for by the Act.
5. No person under the age of 18 years shall be employed in the Club; but this restriction shall not apply to persons employed in the administration of the Club.
6. No unauthorised gambling or betting shall be allowed on the Club premises.
7. Member's pets in the Club grounds shall be suitably restrained and must not be a danger to other persons.
8. No member shall take from the Club premises or injure or destroy any newspaper, periodical, article or thing which is the property of the Club.
9. Damage to any property of the Club shall be paid for by the member causing the damage, and the Committee shall determine the amount to be paid.
10. The Club shall not be responsible for any article whatsoever brought into the Club or surrounds.
11. Children must be under parental control in the Clubhouse and surrounds at all times. The behaviour of children present at the Club shall be the total responsibility of the parents or guardians.
12. Children under 16 years of age must leave the Club premises by 9:00 p.m.
13. The minimum standard of dress on the Club premises shall be SHORTS & TEE SHIRTS until 7p.m.
After this time the minimum standard of dress shall be NEAT CASUAL ATTIRE.
14. Footwear must be worn at all times.
15. It is forbidden to play with bicycles, skateboards, roller skates or any other ride on toys within the Sports Club grounds. Balls can only be played with on the unlicensed open ground adjacent to the Northern car park.
16. All headgear e.g.: hats, caps, beanies are not to be worn within the clubhouse. (Exceptions are made for functions)
